The Fairfax-Falls Church Community Services Board (CSB) offers Intensive Service and Support Coordination, also known as “targeted case management,” which provides a long term, intensive level of service and support coordination for individuals with serious mental illness, serious emotional disturbance, and severe

substance use disorders, and for those who are at risk of serious emotional disturbance and substance use disorders.

Services include:

- Assessment;
- Collaborating with the individual to develop and monitor a service plan;
- Family and community supports;
- Counseling;
- Crisis intervention;
- Intake and discharge planning;
- Helping people access publicly funded and community based services outside the Community Services Board.

In Virginia, Community Services Boards (CSB) are the “local public entities” to provide support coordination for individuals admitted to or discharged from state training centers and for persons diagnosed with intellectual disability who receive community based services. The Fairfax-Falls Church Community Services Board and other CSBs in Virginia have an important role in implementing the settlement agreement between the Commonwealth of Virginia and the United States Department of Justice regarding rights of individuals with disabilities to receive services in their communities.
